Handling Fees

If an order is placed via an exchange or any other trading platform, a handling fee of € 1,00 applies for all products except for Tradegate (Stocks). For stocks traded on UK exchanges, a handling fee of GBP 1.00 applies.

DEGIRO does not charge the fees of third parties directly, but via a handling fee of € 1,00. This fixed fee covers all costs incurred related to the execution of your order (e. g. clearing and settlement costs, brokerage fees, contract note fees, regulatory fees, and execution fees).
